TERMS & CONDITIONS OF PARTICIPATION IN THE OUTLAW TRIATHLON & AQUABIKE EVENTS 2024 ("Event")

Participation in any Event is subject to and conditional upon the following terms and conditions:

1. REQUIREMENTS

- 1.1 Only people properly registered in accordance with these terms and conditions are eligible to take part in an Event ("**Participant(s)**"). These terms and conditions apply to all Charity Participants (as defined in clause 5.1) and, except where specified in these terms and conditions, Participants shall be deemed to include Charity Participants.

Individual Triathlon or Aquabike entry requirements:

- 1.2 Outlaw 'Half' Distance Races - Participants must be at least 18 years old as at 31 December 2024 to participate as an individual and therefore only persons born on or before 31 December 2006 will be able to take part.
- 1.3 Outlaw 'Full' Distance Races - Participants must be at least 19 years old as at 31 December 2024 to participate as an individual and therefore only persons born on or before 31 December 2005 will be able to take part.

Relay entry requirements:

- 1.4 Relay Participants must meet the following age criteria to participate:
- 1.4.1 Swim – 'Outlaw Half' - Participants must be at least 17 years old as at 31 December 2024. 'Outlaw Full' - Participants must be at least 19 years old as at 31 December 2024

- 1.4.2 Bike – ‘Outlaw Half’ - Participants must be at least 17 years old as at 31 December 2024. ‘Outlaw Full’ - Participants must be at least 19 years old as at 31 December 2024
- 1.4.3 Run – ‘Outlaw Half’ - Participants must be at least 18 years old as at 31 December 2024, ‘Outlaw Full’ - Participants must be at least 19 years old as at 31 December 2024

Participants who will be aged under 18 on the scheduled Event date must be registered by a parent, legal guardian or carer on their behalf. Parents, legal guardians or carers registering on behalf of a Participant shall be deemed to have accepted these terms and conditions on the Participant’s behalf and further agree to take full responsibility for such Participant during the Event.

2. ACCEPTANCE OF CONDITIONS

- 2.1 The Event organiser is One Step Beyond Promotions Limited (company number 04986926) whose registered address is Gordon’s House, 10a Greencoat Place, Victoria, London, SW1P 1PH (“**Organiser**”).
- 2.2 The Participant shall be deemed to have accepted these terms and conditions and to have entered into a legally binding contract with the Organiser when they accept the terms and conditions of participation by clicking the relevant field in the online registration form (“**Online Entry Form**”).

3. PARTICIPATION

- 3.1 You represent and warrant to the Organiser that you have full legal authority and capacity to complete the Online Entry Form, including accepting these terms and conditions, on behalf of yourself and/or, where applicable, any party for whom you are registering (the “**Third Party**”), including full authority to make use of the credit or debit card to which fees related to Event Registration will be charged. If registering a child under the age of 18, you represent that you are the parent or legal guardian of that child, or that you have the parent or legal guardian’s prior written consent.
- 3.2 By registering a Third Party, you are confirming to the Organiser that the Third Party meets the requirements set out in clause 1 above and that the Third Party contact details provided are accurate, correct and up to date. The Third Parties will be sent a confirmation email including the link to these Terms to the address provided. By participating in the Event, the Third Party will be deemed to have accepted these terms and conditions. If a Participant is found to be in breach of this clause, their entry shall be rendered void and the relevant Participant(s) and Third Parties shall be disqualified from the Event and the Organiser reserves the right to exclude the relevant Participants and Third Parties from participation in future events organised by the Organiser.
- 3.3 Subject to clause 9, and the provisions relating to relay teams, Participants may not transfer their entry or assign any of their rights or obligations under these terms and conditions, save in accordance with these terms and conditions and/or with the prior written consent of the Organiser. You agree that the entry cannot be given away for free or used as part of any form of business or commercial activity (save as expressly authorised by the Organiser). In particular, the entry may not be resold or offered for resale by anyone whether at a premium or otherwise and may not be used for advertising, promotion use as a prize (including in competitions and sweepstakes), travel packages, or for any other trade purposes (save as expressly authorised by the Organiser). Transfer, donation, give away, resale or attempted resale is grounds for cancellation of entry by the Organiser without refund or other compensation of any kind.

- 3.4 Participants acknowledge that the Event is physically strenuous and that they are aware of the associated medical and physical risks involved. By completing the Online Entry Form Participants warrant to the Organiser that they are sufficiently fit and healthy to participate in the Event unaided (and acknowledge that they must reaffirm that they are sufficiently fit and healthy to participate in the Event unaided on the date of the Event) and agree to be solely responsible for their actions, and the Organiser, its officers, agents, employees, affiliates, sponsors or medical advisers shall not be responsible for any injury or illness that a Participant may suffer as a result of their participation in the Event (unless caused by the negligence of the Organiser or its officers, agents, employees, affiliates, sponsors or medical advisers).
- 3.5 The Organiser reserves the right to remove any Participant from the Event, either during or before it, due to ill health, or any other reason (at the Organiser's discretion) that may render them unfit to safely complete the Event. Each Participant confirms that they will not take part in the Event if they are suffering from any injury or illness which may impair their performance and confirms that they will report any illness during the Event to the Event medical team immediately.
- 3.6 The Participants agree to abide by all Event rules, regulations and instructions issued by or on behalf of the Organiser, any rules and regulations imposed by the venue and all applicable rules and regulations of the relevant sporting governing bodies that oversee the running of the Event including the relevant British Triathlon rules and regulations and doping rules and any road regulations, including without limitation, the Highway Code. The Organiser is entitled to impose Event rules upon the Participants from time to time which will form part of these terms and conditions and all decisions and rulings by or on behalf of the Organiser shall be considered final. The Participants will comply with all instructions and guidelines given by the Organiser and all Event staff, stewards, marshals and medical/safety personnel. The Participants understand that they will not be entitled to a refund of the fees if they are disqualified from the Event as a result of an infringement of these rules, regulations or instructions.
- 3.7 The Organiser shall be entitled at any point to refuse entry to the Event to any person and/or to refuse to allow any Participant to take part or continue to take part in the Event including, without limitation, if they have behaved in a manner which, in the reasonable opinion of the Organiser, has, or is likely to affect the safety of other Participants; or they use threatening, abusive or insulting words or behaviour or in any way provokes or behaves in a manner which may provoke a breach of the peace; or in the reasonable opinion of the Organiser they are acting under the influence of alcohol or drugs or fails when required to produce proof of identity or age.

4. RACE INFORMATION

All necessary race information pertaining to the Event is published on outlawtriathlon.com. Race information is not posted to Participants in hard copy format. However, the Organiser will provide regular newsletters about the Event and inform Participants when new race information is available via email or on outlawtriathlon.com. Please note that details of the Event, as published on the race specific entry form, race information or FAQs are subject to change. Details of any alterations to the race information will be made available on outlawtriathlon.com. It is the responsibility of the Participants to ensure they have accessed the relevant information relating to the Event.

5. PAYMENT

- 5.1 Save for Participants registered to participate on behalf of any official Event charities ("**Charity Participants**"), each Participant is required to pay an entry fee (variable) for the Event at point of entry, or if using the payment plan set out on the relevant Registration Platform (the '**Payment Plan**') at the relevant dates specified therein. The Organiser only accepts payment by approved debit card or credit card.
- 5.2 If payment cannot be collected for any reason including, without limitation, due to insufficient funds, cover of account or revocation by you (including at a later date), the relevant Participant for which the entry was purchased cannot participate in the Event and you may be charged a withdrawal fee.
- 5.3 All entry fees are inclusive of VAT at the prevailing rate as may be applicable at the time of entry. If an entry is accepted the entry fee is non-refundable other than as stated in clause 8 of these terms and conditions.
- 5.4 Processing fees for use of the registration platform used to complete the Online Entry Form (the "**Registration Platform**") will be chargeable in addition to the entry fees and such processing fees will not, under any circumstances, be refunded.
- 5.5 The Organiser will not be liable under any circumstances for any costs incurred by the Participants in relation to the Event, including without limitation any accommodation and/or travel costs.

6. EVENT REGISTRATION

- 6.1 The Participants must complete the appropriate registration process at the time and on the days instructed by the Organiser. It is the Participants' responsibility to make sure that their contact details, entered in the Online Entry Form, are correct. The Organiser cannot be held responsible for being unable to send information if such details are incorrect.
- 6.2 Registration and bike racking will take place the day before the Event. For Participants entering the relay race, only one member of the team is required to register per team. However, the Participant registering on behalf of the rest of the relay team must show photo identification for all relay team members, as referenced in clause 6.3.
- 6.3 For race registration each Participant must present photo identification (e.g. passport, driving licence or BTF Licence). Photocopies or photographs are acceptable. No registration (or racing) will be permitted without providing photo identification in accordance with this clause 6. If a Participant cannot appear personally to register, they must inform the Organiser in writing in advance, nominating an authorised person to register on their behalf on presentation of the Participant's photo identification. Said nominated person must also bring authorisation from the Organiser to be allowed to register.
- 6.4 All Participants must have a British Triathlon Federation (BTF) Race Licence to take part in the Event. If for any reason, a Participant is unable to show a valid 2024 BTF Licence at registration, the Participant will be required to purchase a BTF Day Licence, at the current rate, to be allowed to register. If a Participant has applied for a BTF Day Licence at entry this will be emailed to the Participant in advance of the Event. Relay Team Participants must each show their individual BTF membership or purchase a BTF Day Licence at event registration - this applies to every member of the relay team.
- 6.5 If a Participant needs to change their details, they can do so by logging into their account on the relevant Registration Platform up to 38 days before the Event (see table in section 8). Please note that

changes may need to be made in both the athlete's personal profile and also in the relevant event registration, as the platform may not automatically update. After this time changes must be notified to the Organiser by emailing info@outlawtriathlon.com or calling 01522 699950 (between the hours of 9am until 5pm) but it is the decision of the Organiser as to whether these changes can be accommodated.

7. PARTICIPANT OBLIGATIONS

- 7.1 As a continuing condition of entry into, and participation in, the Event each Participant shall ensure that:
- 7.1.1 a safety approved cycle helmet conforming to British standards is worn at all times during the Bike section of the Event;
 - 7.1.2 they do not start earlier or later than the official start time on the day of the Event. Failure to comply with this rule will result in disqualification;
 - 7.1.3 their bicycle is roadworthy for the Event;
 - 7.1.4 they do not use a mobile phone whilst participating;
 - 7.1.5 they do not use a music player with headphones whilst participating, including bone conducting headphones;
 - 7.1.6 they display the official event numbers provided in the Event race pack in the manner indicated in the event information booklet; folding or defacing event numbers will result in penalties being applied in accordance with the British Triathlon Competition Rules;
 - 7.1.7 they do not deviate from the official signed route of the Event;
 - 7.1.8 they must comply with the British Triathlon competition rules in force, available at britishtriathlon.org/competitionrules;
 - 7.1.9 they must comply with the reasonable instructions of the Organiser and all Event staff, stewards, marshals medical/safety personnel and venue owners;
 - 7.1.10 they shall not intentionally or carelessly litter; and
 - 7.1.11 they shall treat other competitors and other competitor's property, the Organiser and its personnel (including that of its suppliers, volunteers and subcontractors) with respect at all times.
- 7.2 Should Participants breach these terms and conditions, the Organiser reserves the right to (i) disqualify such Participants from the Event, and/or (ii) exclude such Participants from participation in future events organised by the Organiser. In such circumstances, no refunds of any kind shall be payable.

8. WITHDRAWALS

- 8.1 This clause 8 shall not apply to Charity Participants. All cancellations, refunds or withdrawals by Charity Participants must be taken up directly with their designated Charity. No refunds shall be made directly to any Charity Participant by the Organiser under any circumstances.
- 8.2 If a Participant has paid for entry to an Event via a payment plan, Participants will only be entitled to a partial refund pursuant to clause 8.4 once all outstanding payments under such payment plan have

been paid. If payment has been made using Klarna any refunds will be made from the Registration Platform directly to Klarna who will in turn refund directly to the Participant save that any refund processed more than 180 days after purchase will be made directly from the Registration Platform to the Participant.

- 8.3 The Participant acknowledges that places for the Event are limited and registrations for places have a direct impact on the organisation and logistics of the Event. Accordingly, the Participant may only withdraw from an Event as set out in this clause 8.
- 8.4 A Participant may only withdraw from the Event by contacting info@outlawtriathlon.com. All requests for refund must be received by the Organiser at least 38 days before the Event. Emails requesting a withdrawal will be honoured from the date of receipt, but withdrawal must be confirmed 38 days before the Event or within 48 hours of the Organiser's request for confirmation of withdrawal (whichever is later). In the event of a withdrawal, entry fee refunds will only be available in accordance with this clause 8.4:
- 8.4.1 If a Participant has received a discount any refund shall be less the discounted value for that Event.
- 8.4.2 Event entries that have already been deferred or transferred are not refundable.
- 8.4.3 Registration Platform processing fees will not, under any circumstances, be refunded to the Participant.
- 8.4.4 Participants gifted an entry free of charge will not be eligible for any refund or race credit in the event of withdrawal.
- 8.4.5 If a Participant has paid for the Event, provided they have paid the due amounts in full, entry fee refunds will be available as follows:

- 8.5 Any refund of a Participant's entry fee pursuant to clause 8.4 above will be paid by the relevant Registration Platform and for the avoidance of doubt, the Organiser shall be under no obligation to directly refund Participants who registered for the Event via the Registration Platform.

9. TRANSFERS AND DEFERRALS

- 9.1 A Participant can only transfer their Event entry pursuant to clause 9.3. Participants gifted an entry free of charge will not be eligible for a transfer under any circumstances (including pursuant to clause 9.3). For the avoidance of doubt, the transfer of a relay team will affect every team member.

- 9.2 Under no circumstances will Participants be able to transfer their entry to an Event to another person (except as set out in clause 10.2 in relation to Relay Changes). Any Participant found to have transferred or be attempting to transfer their entry to another person or any person found to have taken or attempting to take an entry from a Participant shall be barred from the Event and all future events organised by the Organiser.
- 9.3 **Transfers to another Outlaw event.** Participants may transfer their Event entry to any other Event (excluding Outlaw Half Nottingham) within the same calendar year provided such notice to transfer is received by the Organiser by email (to info@outlawtriathlon.com) at least 38 days in advance of the Event for which the Participant purchased their entry and provided the Event which the Participants wishes to transfer their entry to is still open for entries. Participants may only transfer their entry to another Event once. Please note, once transferred, the Event entry is non-refundable.
- 9.4 The following charges shall be payable in order to secure any transfer (unless clause 9.6 below applies) and must be received by the Organiser 38 days before the Event or within 48 working hours of the Organiser's request for fee payment (whichever is later):
- 9.4.1 £30 transfer fee;
 - 9.4.2 any additional registration fees where the new event is more expensive
 - 9.4.3 any price increases for the new Event (if applicable); and
 - 9.4.4 any Registration Platform processing fees that apply at the time of transfer (if applicable).
- 9.5 Participants transferring from Outlaw Nottingham (The Full) to a Half distance Event will be given a credit for the difference in entry fee, minus the transfer charge (if payable), no refunds will be payable on the entry fee.
- 9.6 Participants who registered for an Event at least 90 days before the Event date will be entitled to a single transfer of their entry (pursuant to clause 9.3 above) but will not be required to pay the £30 transfer fee.
- 9.7 **Deferrals.** A Participant can only defer their Event entry pursuant to clause 9.7 or 9.8 below. This clause shall not apply to Charity Participants. All deferrals by Charity Participants must be taken up directly with their designated Charity. No deferrals can be granted to any Charity Participant by the Organiser under any circumstances. Participants gifted an entry free of charge will not be eligible for a deferral. For the avoidance of doubt, the deferral of a relay team will affect every team member.
- 9.8 Participants who registered for an Event at least 90 days before the Event date are eligible to defer their Event entry to the same Event in 2025 provided such notice to defer is received by the Organiser at least 38 days in advance of the 2024 Event via email (to info@outlawtriathlon.com). Emails requesting a deferral will be honoured from the date of receipt, but deferral must be confirmed 38 days before the Event or within 48 hours of the Organiser's request for confirmation of withdrawal (whichever is later). Participants may only defer their entry once. Once deferred, the entry is non-refundable and non-transferrable.
- 9.9 A Participant that becomes pregnant after entry may opt to defer their entry to the same Event in 2025 or 2026 provided that such Participant has provided proof of pregnancy (e.g. Note from Doctor or Midwife) to the Organiser at least 38 days in advance of the 2024 Event via email (to info@outlawtriathlon.com). The Organiser reserves the right to request additional verification and to deny a deferral if the proof provided is deemed insufficient. Once deferred, no further deferrals can be made, and the entry becomes non-refundable.

9.10 Entry links provided for deferred entries will be issued to the email address provided for the original entry and must be claimed by fully completing the entry process within 1 month of issue or by the specified expiry date, whichever is sooner. It is the Participant's responsibility to ensure that the email address provided is correct and that they complete the registration specified process within the timeframe specified by the Organiser.

9.11 The deadlines and notification dates for transfers and deferrals for each Event are as follows:

10 ENTRY TYPE CHANGES

10.1 **Transfer from individual to a relay entry.** Participants may change their entry from an individual entry to a relay (where a relay option is available), provided such notice to change entry is received at least 38 days in advance of the Event. The following charges shall be payable in order to secure such transfer:

10.1.1 £10 transfer fee; and

10.1.2 £30 for the increase entry price of a relay team in the case of an Outlaw Half Event, £40 for the increase in entry price for Outlaw Nottingham; and

10.1.3 any Registration Platform processing fees that apply at the time of transfer (if applicable).

10.2 **Relay changes.** Relay teams may swap team members up to 16 days prior to the scheduled Event date by calling the Organiser on 01522 699950 (between the hours of 9am until 5pm). Failure to register members may result in disqualification for the entire team.

10.3 **Relay to individual entry.** The team captain of a relay team may transfer their entry to an individual entry, provided such notice to transfer is received at least 38 days in advance of the Event. If transferring to an individual entry, no refunds will be payable on the entry fee. Registration Platform processing fees will also be payable. For the avoidance of doubt, the entire relay team cannot transfer to individual entries.

11 CANCELLATION, ALTERATION AND TIMINGS OF EVENT BY THE ORGANISER

11.1 The Participant acknowledges and accepts that circumstances concerning the Event may change from time to time for reasons outside of the Organiser's reasonable control or otherwise, without the Organiser incurring any liability and without any rights to withdrawal being accrued by the Participants save as expressly set out in these terms and conditions.

- 11.2 The Organiser may cancel the Event due to circumstances beyond the reasonable control of the Organiser including, without limitation, (i) acts of God, flood, drought, earthquake or other natural disaster; (ii) epidemic or pandemic; (iii) terrorist attack, civil war, civil commotion or riots, war, threat of or preparation for war, armed conflict, imposition of sanctions, embargo, or breaking off of diplomatic relations, or threats thereof; (iv) nuclear, chemical or biological contamination or sonic boom; (v) any law or any action taken by a government, public authority or governing body, including without limitation imposing any advice or restriction against events or gatherings, export or import restriction, quota or prohibition, or failing to grant a necessary licence or consent or period of national mourning; (vi) collapse of buildings, fire, explosion or accident; (vii) any labour or trade dispute, strikes, industrial action or lockouts; (viii) non-performance by suppliers or subcontractors (including any venue); and/or (ix) interruption or failure of utility service.
- 11.3 In the event of cancellation under clause 11.2, Participants will not be entitled to any refund of: (i) the entry fee; (ii) any Registration Platform processing fees; or (iii) any other losses, such as travel or accommodation expenses.
- 11.4 If the Organiser cancels the Event pursuant to clause 11.2, the Organiser shall, to the extent possible, provide a free transfer to another of the Organiser's events.
- 11.5 The Organiser reserves the right to change the date of the Event. In the event of such change of date of the Event, and if a Participant is unable to attend on the revised date, they have 7 days to inform the Organiser in writing from when the change in date is announced to receive a refund of their entry fee (excluding any Registration Platform processing fees).
- 11.6 The Organiser reserves the right to alter the start time of the Event. In the event of a change of start time the Participant will be notified of the revised start time with as much notice as reasonably practicable. The Participants acknowledge that if the Event will have an earlier start time, it is the Participant's responsibility to ensure that they arrive at the time allocated to them. No refund in full or in part shall be made for any change in start time for the Event provided the Event takes place on the specified date of the Event.
- 11.7 The Organiser reserves the right to amend the Event format, including changing the course and the distance, at its sole discretion. If the Event format, course or distance, is changed the Participant will not be entitled to any refund and there shall be no further liability whatsoever arising from such change of format, course or distance.
- 11.8 In order to ensure the roads can re-open on time in line with the Organiser's obligations to the relevant local authorities and to ensure the proper functioning of the transition areas, the Organiser has the right to remove, from the Event, those Participants who do not meet the applicable required cut-off times. No refunds will be paid to Participants in these cases. The relevant cut-off times can be found at outlawtriathlon.com, and are subject to the change at the Organiser's discretion.

12 LIABILITY AND INSURANCE

- 12.1 Participation in the Event is at the Participant's own risk. Each Participant irrevocably agrees to hold harmless, indemnify and reimburse the Organiser and its affiliates from and for any liability, sum, costs, damages or expenses (including legal and professional fees) incurred by the Organiser and its affiliates in connection with any accident, loss, damage or injury (including death) arising out of the Participant's attendance at and participation in the Event or any part thereof (except where any such injury or death is caused by the negligence of the Organiser or any of its employees).

- 12.2 Under no circumstances shall the Organiser and its affiliates be liable to each Participant in contract, tort (including negligence) or otherwise for any loss of business, revenue or profits, charity funds, anticipated savings or wasted expenditure, or any indirect or consequential loss or damage whatsoever (notwithstanding that such loss was within the contemplation of the parties at the date of submitting the Online Entry Form) arising out of the Participant taking part in the Event or any other matter arising under these terms and conditions nor for an aggregate amount greater than the entry fee (excluding Registration Platform processing fees) paid by the Participant.
- 12.3 In the event of cancellation of the Event or a Participant's entry for any reason, the Organiser will have no responsibility for any costs or expenses incurred by a Participant in relation to an Event as a result of cancellation, including any travelling or accommodation expenses.
- 12.4 Nothing in these terms and conditions shall exclude or limit the liability of the Organiser:
- 12.4.1 for death or personal injury caused by the Organiser's negligence;
